

## YK Dance Arts Ltd. 2026 Recital Policies & Media Release Waiver

**Recital Payment policy:** Dancers must pay the recital fee to receive their costume rental and participate in the recital with their class. Dancers not participating do not need to pay the recital fees or sign this waiver.

**Recital fees due:** \$68+GST per-dancer/per-class. (e.g. If a dancer is in two classes, \$136+GST is due. For three classes, fees are \$204+GST.) **Due Feb 20 2026.** Fees contribute to:

- costume & accessory rental (**to be returned by June 6 2026**)
- shoes (**to be returned by June 6 2026**, if needed [not all costumes will require shoes])
- tights (to keep, if needed [not all costumes will require tights])
- costume alterations and cleaning
- Northern Arts and Cultural Centre (NACC) theatre rental, staffing, and insurance costs
- videographer & photographer fees
- administration/work time to coordinate all of the above.

### Payment Options:

**1. Preferred payment method:** E-transfer payment in full (non-refundable). Due Feb 20 2026. Invoice and receipt will be emailed. Please do not e-transfer until you receive an invoice.

**2.** Online credit-card payment in full (non-refundable). Due Feb 20 2026. Invoice/payment link, and receipt will be sent by email.

### Conditions:

- 1.** Payments are **non-refundable**. If your dancer misses the performance or changes their mind about participating, fees will not be refunded.
- 2.** All fees are subject to GST.
- 3.** Any fees incurred for declined credit cards or incomplete transactions will be charged back to the client responsible.

### Attendance and Absence Policies:

- 1. Please prioritize dance class attendance during the months leading up to your child's performance.** Dancers will learn what to do onstage and practice together during our regular class time. Dancing as a group requires commitment from every individual on the team. Dancers who miss classes or are late regularly will not be prepared.
- 2.** Please notify YK Dance Arts ahead of time if your child will miss a class, dress rehearsal, or performance.
- 3.** Missed dress rehearsals, performances and classes are non-refundable.

## General Policies:

1. NO chewing gum onstage or backstage at the NACC.
2. Dancers may bring snacks/water for backstage. All messes must be cleaned and garbage disposed. Please pack simple snacks that won't make a mess of our costumes or the backstage area if spilled.
3. Please drop-off your dancer(s) on time for **CALL TIME** (tbd). Volunteers will be working hard to ensure your dancer can get from the drop off area to the backstage area. Dancers that are late may miss their performance on stage.
4. Dancers should show up ready to get onstage with their costume on and hair done. Dancers are to wear the provided costume for their performance. Guidelines for hairstyles and stage-makeup (optional) will be provided. Please reach out to [ykdancearts@gmail.com](mailto:ykdancearts@gmail.com) if there is an issue with your dancers costume or if they require a costume accommodation. **Costume & shoe rentals will be returned by June 6 2026.**
5. Dancers with multiple classes should come dressed in their first costume, and bring the others with them to change into when required.
6. Please meet your dancer in the theatre lobby area promptly after the end of the show.
7. Students with injuries may not be permitted to participate.
8. The event may be cancelled in the event of insufficient participant enrollment, teacher illness/personal emergency, or other unforeseen events (e.g. power outage, wildfire, pandemic)
9. Dancers are not permitted to leave the supervised backstage area to other areas of the NACC/Sir John High school during the show.
10. Audience members are not permitted to film or photograph during the performance. It is an impolite distraction to other audience members and the performers on stage. Professional photos/video will be made available to participants after the show.
11. Please leave unnecessary valuables at home. YK Dance Arts Ltd. and the Northern Arts and Cultural Centre are not responsible for any lost or stolen items.
12. YK Dance Arts Ltd. and the Northern Arts and Cultural Centre are not responsible for any injuries that may result from the services offered or that happen anywhere on the Northern Arts and Cultural Centre property.

## Media Release:

Signing this waiver/media release gives permission for YK Dance Arts Ltd. to use the listed children's name and/or images in the media. This could include the recital cast list/programming, YK Dance Arts website, social media, or other platforms where news/media can be shared publicly.

A modified media release form may be made available if you are uncomfortable with the above terms. **Please contact [ykdancearts@gmail.com](mailto:ykdancearts@gmail.com) if you have any questions/concerns before signing, or if you require a modified media release** (e.g. arrangements may be made to blur/cover your child's face, or other terms you are comfortable with). Please note that YK Dance Arts Recitals are public events that may be covered by outside media sources and where individual community members may take photos for personal use. YK Dance Arts encourages everyone to seek consent from the included individuals when posting personal photos/videos online.
